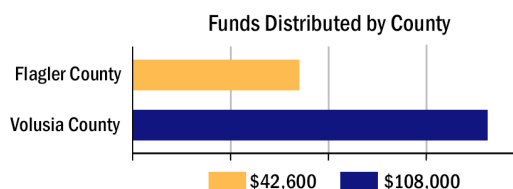

## STORIES OF IMPACT



**COVID-19 Relief Grant at work:** "I've never needed assistance before, but when both my husband and I were laid off because of the virus we had no other options," said Claire. Their family burned through their savings quickly to pay for necessary bills and feed their 3 children. She expressed embarrassment at

needing support, but reached out to one of United Way's partner agencies, the Jewish Federation of Volusia-Flagler Counties, that offered food assistance for her family. Claire called back to the agency after receiving the food saying, "I am so amazed at the food provided and we can't thank you enough. This is the support we needed to figure out our next steps as a family."



Sara had reached the end of her rope. After suffering abuse at the hands of her boyfriend and in front of her children, she decided to make a change. Sara reached out to the Family Life Center through their

hotline to ask for help. Even with her determination and a plan for her future, she needed the support of the caring FLC team to accomplish her goals. Thanks to FLC staff, support groups, and family, she was able to receive counseling, employment and stability for her children. With Sara's determination and the support of Family Life Center she was able to secure her first ever independent housing, buy her first car, and become a much stronger version of herself.
